Dear Governor Reeves:

In accordance with the Mississippi Medical Cannabis Act (the Act), I am pleased to share with you the required annual report for the Mississippi Medical Cannabis Program. Upon passage and your signature of the Act in February 2022, the Mississippi State Department of Health and the Mississippi Department of Revenue began working together to bring the medical cannabis program to fruition in our state. Collaboratively, both agencies met their ambitious deadlines to establish rules and regulations and begin issuing business licenses, dispensary licenses, patient registry identification cards, and work permits as required by the Act.

To date, two hundred forty-two (242) new businesses have been licensed in this very new industry in Mississippi. Please see the enclosed data for a breakdown of business types. Eight hundred sixty- nine (869) work permits have been issued, allowing individuals to gain employment in Mississippi's medical cannabis industry.

Since its inception, the Medical Cannabis Program has generated just over 9.8 million dollars through application and licensure fees. All fees set by the Act remain unchanged. As this new industry is establishing itself and gaining momentum, we are hopeful that our state will see substantial revenue from the collection of taxes associated with the industry. Due to business startup, there have been no retail sales of medical cannabis. We anticipate that retail sales will begin during the first quarter of calendar year 2023.

Through the compliance and regulatory activities of both agencies, we expect that fines will also bolster revenue associated with the Medical Cannabis Program. During the first six months of the program, there have not yet been any fines collected.

I want to specifically acknowledge our partner agency, the Mississippi Department of Revenue, and the staff of the MSDH Medical Cannabis Program for their relentless efforts in executing the program. As the program continues to evolve and make improvements in efficiencies and operations, I eager to see the public health impacts it has on our citizens.


